##### **Refund Policy:**

Registrants unable to attend the conference in-person may submit a cancellation request. Notice of cancellation should be emailed to [info@ahvap.org](mailto:info@ahvap.org). AHVAP can't be held liable for nonrefundable airline tickets, hotel, or other costs. 70% of your registration fees are refundable if written notice is received by 5:00 P.M. Eastern on August 22, 2025. No-shows are non-refundable. Any refunds due will be issued once the Conference ends. After August 22, 2025, all fees/credits toward the Conference are forfeited. Please allow 6-8 weeks for all refunds to be completed.
